# 1. The Conference:

The world is undergoing rapid and extensive changes associated with globalization, conflicting ideas about the roles of the State and the reconfiguration of communities. The Social Economy contains several approaches that could be of use to communities, social entrepreneurs, policy makers, community activities and researchers (both within and without the academy).

# 2. Conference Goal:

To highlight the role of the Social Economy in building and strengthening communities in a variety of contexts and cultures.

# 3. Objectives:

- 1. To bring together Social Economy researchers and practitioners from across the world.
- 2. To explore public policy issues on the Social Economy and the role of research.
- 3. To strengthen the importance of participatory research between researchers and practitioners in the Social Economy.
- 4. To provide researchers, practitioners and governments the opportunity to exchange information and viewpoints on the Social Economy in different national contexts.

# 4. Definition of the Social Economy for the purpose of the conference:

The **Social Economy** has been defined in the work of the Canadian Social Economy Hub as: "Separate from the private sector and the government, the Social Economy includes cooperatives, foundations, credit unions, mutuals, non-profit organizations, the voluntary sector, charities and social economy enterprises."

# 5. Organizing Organizations:

# **CIRIEC International (Centre of Research and Information on the Public, Social and Cooperative Economy)** is a research organization on economic sectors and activities orientated towards the service of the general and collective interest, including:

- Action by the public authorities in economic fields (economic policy regulation)
- Public utilities
- Public and mixed enterprises at the national, regional and municipal levels;
- The Social Economy (not for profit economy, cooperatives, mutuals, and non-profit organizations)
- Workers' participation

CIRIEC-Canada, Center for interdisciplinary research and information on collective enterprises is interested in organizations and economic activities directed towards the general or collective interest. It was founded in 1967, as a national section of CIRIEC International. CIRIEC-Canada aims to contribute to the development of this form of economic activity with an enlightened and critical support. CIRIEC – Canada is a center of expertise in research, formation and support for the development of the social and interdependent economy. The review of CIRIEC-Canada, "Economy and Solidarity", is one of the only scientific reviews in the French language dedicated to the enterprises of the collective economy. At the present time, the council of CIRIEC-Canada is made up of researchers coming from all the French language Québec and Canadian universities, and from the representatives of some of the most important public companies, co-operatives and social economy organizations.
